Treasurer's Report: Financial Year 01.01.23 to 31.12.23

Friends of Selsdon Wood (FSW) ended 2023 with a credit balance of £7,057.97 (2022 £6,284.46).

INCOME

The bulk of the income in 2023 arose from Membership Fees & Donations, and a Grant (for the renovation to the Lindon Glade Pool – see below for breakdown of costs and income). Further income is raised through the production of a Calendar and the annual Open Day Event. For further details, see End of Year Accounts and information below.

MEMBERSHIP

Members/Households: 142 members had either joined or renewed membership during 2023

Chair status: 11 members/households - This is a convenient classification for generous members, who make donations from time to time. (in 2023 6 chair members made a donation).

Honorary members: 18 members/households - who have or are giving service to or are useful contacts, for FSW. They never pay subs but some may donate. **Note:** it was decided that FSW will not offer Life membership.(in 2023 one honorary member made a donation).

2024 CALENDARS (Led by Heather Govier)

For the twelfth year FSW has produced a Calendar, the Calendars were taken by local people for a donation of £5 and thus generated additional income to FSW. (note the income statement shows £521 for calendars as some monies were for the 2023 calendar).

OPEN DAY (Led by Linda Morris0

This event, was held on 3rd September 2023.

Calendars: 21 visitors gave a £5 donation for one of these beautiful calendars showing photographs

taken during the previous year(s) in Selsdon Wood.

Membership: 11 new/existing members took the opportunity to join at the Open Day and one existing

member renewed their membership.

Tombola £185.81 was raised less £22.99 relating to purchase of prizes giving a net income of

£162.82

White Elephant £113.90 including income from the jewellery stall run by Valerie.

Stall Holders: £40 was raised through the generous donations from Stall Holders

Photo Competition: The photo competition was back in 2023 and proved v popular, prize monies were once

again generously donated by Tony Flecchia.

EXPENDITURE

The upkeep of the woods by FSW continues to impact on expenditure. £2,112.26 was spent on tools and equipment, this included 2 electric trolleys to carry equipment etc., a brush cutter for workdays plus other smaller items, and equipment associated with organized walks, first aid supplies, & PPE.

Other notable expenditure related to the Public Liability and Tools Insurance cover (£269.94).

PROJECTS

Linden Glade Pool

In January 2023 it was agreed that the FSW would undertake to refurbish the Linden Glade Pool which was in a state of disrepair, resulting in a cracked liner that meant the pool lost water and valuable wildlife was unable to use it, also as the pool was unfenced it meant that dogs could get in it. The project involved relining and fencing off the area, and replanting (which has still to be completed. A Just Giving page was set up and also a grant applied for.
