Treasurer's Report: Financial Year 01.01.24 to 31.12.24

Friends of Selsdon Wood (FSW) ended 2024 with a credit balance of £5,784.72 (2023 £7,057.97).

## **INCOME**

The bulk of the income in 2024 arose from Membership Fees & Donations, Further income is raised through the production of a Calendar and the annual Open Day Event together with Just Giving and Easy Fundraising donations. For further details, see End of Year Accounts and information below.

#### **MEMBERSHIP**

Members/Households: 143 members had either joined or renewed membership during 2024

**Chair status:** 11 members/households - This is a convenient classification for generous members, who make donations from time to time. (in 2024 5 chair members made a donation totalling £192).

**Honorary members:** 18 members/households - who have or are giving service to or are useful contacts, for FSW. They never pay subs but some may donate.

### **2025 CALENDARS** (Led by Heather Govier)

For the thirteenth year FSW has produced a Calendar, the Calendars were taken by local people for a minimum donation of £5 and thus generated additional income to FSW. (note the income statement shows £155.83 for calendars as a further £218 was paid in to the bank in January 2025 and will show in the 2025 accounts.

#### **OPEN DAY** (Led by Linda Morris0

## **WOOD CARVINGS**

The wood carvings have been a very popular project with the local community and this was reflected by how much was raised from the Just Giving appeal, a total of £1,555 was raised towards the cost of the carvings and their ongoing maintenance (linseed oil etc.).

### **EXPENDITURE**

After purchasing equipment and trollies in 2023 the group spent little on tools and equipment in 2024, £248 was spent on plants etc. for the Linton Glade pool, and £491 on bird food etc. for the bird feeding station. The main area of expenditure was the wood carvings project where £3,109 was spent on the carvings and oil to maintain them.

Also the dilapidated fence at Yew Tree Way was removed early last year for a cost of £120.

Other notable expenditure related to the Public Liability and Tools Insurance cover (£269.94).
